Additional Services

While we have listed the most popular services in our guide, there are many others offered by discount brokers. Some firms, for instance, have offices in many locations, a consideration for

investors who want the reassurance of a local contact. Check with the firm for a list of branch-office locations if this is an important consideration to you. Most of the discount brokers listed here have toll-free phone numbers, so there is no charge for calls regardless of where they are located.

Some brokerage firms offer asset management accounts with check writing privileges, debit cards, the direct deposit of payroll checks and other checks, and ATM access cards.

Most discounters offer the standard broker fare of margin accounts, wire transfers, confirmations of trades, and monthly statements.
