[We hope you back your ideas just like Jeff Bezos does... boldly.] Though our contest has a one-year time horizon, we welcome ideas that have shorter or longer shelf life. You can always claim victory by saying your time horizon was whatever time span during which your investment had gains.

Please try to bring 20 copies of a data sheet or a research article that was useful in your decision making to hand out to other attendees so they can fully appreciate your analytical genius.

Speaker / Discussion Leader: Alan J. Liebman

Alan Liebman has been helping investors for more than three decades. He earned a bachelor's degree from Columbia University in physics and a doctorate from Yale in applied physics. Liebman worked in corporate R&D at Xerox Corporation and AT&T for 15 years.

In 1984, Liebman founded American Superior Company in suburban Chicago, a fee-only investment advisory firm. During 32 years of practice, Alan has published a stock

market advisory letter, managed stock and bond assets of \$60 million, led monthly meetings of AAll-Chicago groups, served as Vice President of the AAll-Chicago Board, and lectured across the country on investment topics.

In 2011, Liebman moved American Superior Company to Reno, Nevada where he continues to serve high-net-worth clients in six states and to help all investors make more informed choices.
